





Requirements for becoming a CSE Licensed Trainer + Consultant

For Consulting Firm Owners ONLY

Minimum Criteria Required

- Become a Certified Sustainability (ESG-P) Practitioner (or have an updated Certificate) prior to Licensing.
- Have a 3 to 5-year experience in offering consulting services and be an owner a consulting firm, smaller or bigger (Consulting Freelancers are not eligible to become Affiliates)
- Access to local business networks in various sectors
- Client references and case studies available
- Trainers will have to be qualified by CSE (For Licensed Trainer only)
- Capacity to organize and Market training programs (For Licensed Trainer only)

C.Subscription Fee to become a CSE Licensed Trainer + Consultant \$9,500 per year
