## DESCRIPTION



Upon successful completion of the three-day live sessions, you will have the chance to complete a sustainability plan that will qualify you for earning the globally recognized Sustainability ESG Certification. To be eligible for certification, participants must attend at least 60% of the Live Sessions via zoom platform. Within 15 business days you will submit your assignment for review and evaluation.



About two weeks after you submit your assignment, you will get your first Certification (Certified Sustainability ESG Practitioner) and the respective Seal. (Under the condition that your Assignment submission is successful). Once you complete the certified online course, along with the final quiz and assignment, you will receive your second Certification (specialization) and a badge.



With the completion of the 3rd live session of ESG Practitioner Program, you will be given three months to decide when you would like to start the Certified Specialization Course. You will be given 45 days access counting from the day the Certified Specialization Course will be assigned to your account to complete it (Certificate of Specialization).

If you fail the Certified ESG Practitioner – Live Sessions assignment, you can still earn the relevant certificate of the online course. If you fail the Certified ESG Practitioner assignment, you may resubmit it after 3 months with an additional fee.



If you fail the final quiz or assignment of the Certified Specialization Course, you are allowed to retake it one more time.

If you are unable to complete the Dual Certification process within the specified time limits, an extra fee will be applied.
